

## **Instructions for the use of the WIC Program Non-Discrimination Statement**

As per FNS instructions dated May 5, 2022:

### **English**

In accordance with federal civil rights law and U.S. Department of Agriculture (USDA) civil rights regulations and policies, this institution is prohibited from discriminating on the basis of race, color, national origin, sex (including gender identity and sexual orientation), disability, age, or reprisal or retaliation for prior civil rights activity.

Program information may be made available in languages other than English. Persons with disabilities who require alternative means of communication to obtain program information (e.g., Braille, large print, audiotape, American Sign Language), should contact the responsible state or local agency that administers the program or USDA's TARGET Center at (202) 720-2600 (voice and TTY) or contact USDA through the Federal Relay Service at (800) 877-8339.

To file a program discrimination complaint, a Complainant should complete a Form AD-3027, USDA Program Discrimination Complaint Form which can be obtained online at:

The letter must contain the complainant's name, address, telephone number, and a written description of the alleged discriminatory action in sufficient detail to inform the Assistant Secretary for Civil Rights (ASCR) about the nature and date of an alleged civil rights violation. ### **Spanish**

De conformidad con la Ley Federal de Derechos Civiles y los reglamentos y políticas de derechos civiles del Departamento de Agricultura de los EE. UU. (USDA, por sus siglas en inglés), se prohíbe que el USDA, sus agencias, oficinas, empleados e instituciones que participan o administran programas del USDA discriminen sobre la base de raza, color, nacionalidad, sexo, discapacidad, edad, o en represalia o venganza por actividades previas de derechos civiles en algún programa o actividad realizados o financiados por el USDA.

Las personas con discapacidades que necesiten medios alternativos para la comunicación de la información del programa (por ejemplo, sistema Braille, letras grandes, cintas de audio, lenguaje de señas americano, etc.), deben ponerse en contacto con la agencia (estatal o local) en la que solicitaron los beneficios. #### **Font size**

Required font size for the non-discrimination statement is 11 point or larger. It must be printed in a standard font in black or other dark color.

#### **Abbreviated Statement**

If the material is too small for the full statement (a single page document, post card, etc.) you may print the abbreviated statement its place. This statement should be in a font size no smaller than the body text of the document:

#### **Spanish**

Esta institución es un proveedor que ofrece igualdad de oportunidades.

#### **Spoken Media**

Radio and television public service announcements must include the statement:

This institution is an equal opportunity provider.

#### **Exceptions**

Small items such as pens, buttons, cups, and magnets are not required to have the non-discrimination statement. Nutrition education and breastfeeding promotion materials that make no mention of WIC Program benefits or requirements are not required to have the non-discrimination statement. Forms & letters for office use are not required to carry the statement if they are not seen by nor sent to participants or the public.
